

# New Minas Village Commission

## *Minutes of Meeting*

**September 15, 2003**

**Meeting Called to Order**

*Chair Nicholson called the meeting to order. He recognized former Commissioner Paul Swanburg*

**Approval of minutes**

***On motion of Commissioner Messom and seconded by Commissioner Chaulk, the minutes of the Commission meeting August 11, 2003 be approved as circulated.***

*Commissioner Swanburg suggested that the word “potential” in line 2 of page two be changed to “alleged”. A discussion took place regarding the intent of the response to Mr. Barrett’s issue of collection of accounts. Ms. Swanburg indicated that her understanding was that the Commission would meet prior to having the Solicitor provide advice on the matter.*

***Motion carried, with the amendment on Page 2.***

**Approval of agenda**

*Ms. Swanburg requested that the issue of use of Village-owned vehicles be placed on the agenda. Other Commissioners did not agree. Mr. Ramsay was asked to place the issue on the next meeting.*

***On motion of Commissioner Messom and seconded by Commissioner Chaulk the agenda is approved. Motion Carried.***

**Presentation Mr. T. Gideon**

*Mr. Gideon asked the Village to consider the provision of a flashing light at the intersection of Dow Rd. and Commercial St. due to the pedestrian traffic. He also suggested that the crosswalk lines be painted, along with increased public education and law enforcement. He requested an update on the collection of the overdue account of Cavalier Contracting.*

**Recreation Committee Report**

*Ms. Swanburg presented the report as circulated.*

***On motion of Commissioner Chaulk and seconded by Commissioner Messom the Committee report be approved, including the appointment of Tim Hendricks as a member of the Committee. Motion Carried.***

*The Chairman advised that no meeting has been held.*

First Reading  
Amendment to ByLaw  
#1 Meetings

**On motion of Commissioner Chaulk and seconded by Commissioner Swanburg the By Law move to second reading. Motion Carried**

*The amendment changes the time of the regular meeting to 7:00 PM.*

Collection of overdue  
accounts

*Commissioner Swanburg indicated that she is not in favour of receiving the advice of the Solicitor before the Commission meets to discuss the issue. The Chairman requested the advice of the Solicitor. The Solicitor advised that the issue of the affidavit and the related alleged should be brought to the attention of the RCMP, and since this is an employee related issue, the Commission must discuss this in camera.*

*A motion of Commissioner Swanburg that the Commission discuss the issue prior to getting the Solicitor opinion was not seconded.*

***On motion of Commissioner Chaulk and seconded by Commissioner Swanburg an in camera meeting be held immediately following the regular meeting tonight to discuss the issue. Motion Carried.***

Wellness/Recreation  
Project

*Commissioner Swanburg presented a report on behalf of the Committee. She advised that the Committee recommends that a consultant be engaged to provide the services as outlined to the Commission. The Committee wants approval to spend approximately \$1,000 to have drawings prepared. The letter from Mr. Giddens suggests that the Commission request Mr. Ramsay to carry out the services as part of his contract with the Village. Ms. Swanburg reminded the Commission that it has a Purchasing and Tender Policy to abide by. Mr. Ramsay advised that as a potential bidder, he does not intend to be involved in the process.*

***On motion of Commissioner Swanburg and seconded by Commissioner Messom, the Village Commission call for proposals to carry out the services as outlined to the Commission, and that Kings CED be requested to assist in the Call for Proposals project for the Commission. Motion Carried.***

Flooding Laurie Ward  
Property

*The Commission discussed a report from Hiltz and Seamone outlining the problem of flooding of Laurie Ward. Peter Pothier recommended that the Commission not perform work on private property, as the citizens initially requested that the sidewalk be paved.*

***On motion of Commissioner Messom and seconded By Commissioner Chaulk the Village refuse to carry out any work to alleviate the flooding on Mr. Ward's property. Motion Carried.***

Proposed subdivision

A report was presented by Hiltz and Seamone indicating that the Village

sewer and water system has the capacity to handle the 82 lots in the proposed subdivision. Commissioner Chaulk inquired what the financial impact would be on the water commission and sewer services.

**On motion of Commissioner Messom and Commissioner Chaulk, the matter be referred to the Village Engineer for the financial impact review. Motion Carried.**

**Approval of accounts**

***On motion of Commissioner Messom and seconded by Commissioner Chaulk the accounts as presented be approved.***

*Commissioner Swanburg requested information regarding the invoice of Red Castle Publishing.*

***Motion carried.***
